The AURA PTL II Clinical System/Homeopathic, Nutritional and Energetic Remedies

The *AURA PTL II* Clinical System is a complete approach to energetic balancing and improving health by combining LLLT (Low Level Light Therapy), homeopathic remedies, dietary recommendations, exercise and dietary supplements. I have read the additional, attached description of the system and had any questions satisfactorily answered.

This approach has not been proven to, nor is it offered to, diagnose, mitigate or treat any condition or disease. Energetic work and suggested remedies are not intended to replace any medication or treatment currently advised or prescribed by any health care practitioner; patients should continue any treatment they are currently undergoing. Patients who are pregnant or may be pregnant, wear a pacemaker, or who have suffered anaphylaxis should not participate in this program.

These methods are not widely accepted by the medical or chiropractic communities and have not been established in the scientific literature as proven to have any benefit. They are considered a form of complementary and alternative medicine (“CAM”). The integrated use of LLLT and energetic substance frequencies for use in supporting physical health has been adopted by some CAM practitioners but is controversial. The use of homeopathic remedies and dietary supplements in supporting and maintaining health also remains controversial.

An Important Word about Allergies and Sensitivities. Diagnosis of allergies or other medical conditions should be pursued by conventional diagnostic methods. The absence of any finding should not be considered to indicate that disease is not present. For diagnosis and treatment of medical conditions, your physician/practitioner may wish to order additional tests, and you should confer with your primary care physician or appropriate specialist. Patients who have been diagnosed with a true allergy should follow their physician’s instructions with regard to avoidance and treatment, even after any work with the *AURA PTL II* Clinical System or use of homeopathic medications/supplements.

Risks/Adverse Reactions. Optional Electrodermal Screening is non-invasive procedure and the skin will not be punctured during testing. The voltage used is too small for most individuals to even feel. The procedure is very safe because it measures only changes in the electrical properties of the skin. In addition to the risk of false positive or false negative results, extremely sensitive individuals may on rare occasion experience an aggravation of their symptoms from to the electromagnetic signal of the remedy being tested. There are generally no risks associated with the substances recommended to create energetic equilibrium. On rare occasions, individuals may experience allergic reactions to recommended dietary supplements. It is also possible in unusual cases when desensitizing sensitivities that they may increase, at least momentarily.

Infra-red lasers are used for biostimulation to provide pain relief and to reduce inflammation. These products emit light and radiation within allowed ranges that are considered safe. While full-powered medical lasers have potential side-effects ranging from temporary redness, swelling,



and lingering warmth to blistering, bruising, and scarring, the intensity a red 635nm <5mW laser are far less and present little risk. Any laser light should not be directed into the eyes.

No Guarantee /Assumption of Risk. AURA PTL II Clinical System and the balancing of bioenergies is an art as well as a science, and results can be unpredictable. In some cases, sensitivities do not respond to this method and results cannot be guaranteed. Any exposure to allergens after a LLLT session is done at the patient's own risk. Exposure to allergens can bring serious, life-threatening symptoms, including difficulty breathing, difficulty swallowing, abdominal pain, cramps, vomiting or diarrhea. Further, even if improvements are experienced, it is not possible to guarantee that they will not return or that new sensitivities will not develop in the future. I agree to assume the risks that have been addressed above and explained to me for adverse reactions, understand that immune reactions can be unpredictable, and that it is possible to experience increased symptoms.

Your Responsibilities. It is important that any significant health problems, such as diabetes or high blood pressure, and information regarding serious allergies be disclosed prior to the session. Immediate medical attention should be sought in the event any significant symptoms arise after the session or if an allergic reaction occurs after any food or environmental exposure. Please report any discomfort experienced from the session or from taking recommended remedies/supplements.

The AURA PTL II Clinical System/Homeopathic and Energetic Remedies

The AURA PTL II Clinical System is a complete approach to energetic balancing and improving health by combining LLLT (Low Level Light Therapy), homeopathic remedies and dietary supplements. This system is designed to improve self-regulatory processes that play a role in our ability to cope with environmental and other stressors. The approach begins with galvanic skin resistance measurement of neurological responses to possible stressors. A low-level laser is tuned using this information to assist the body in resetting these self-regulation mechanisms and changing its response to these stressors, thus reducing inflammatory responses. This information, along with a clinical assessment including history and symptoms, is used to formulate recommendations for natural remedies, exercise, stress reduction, detoxification, and/or nutritional changes designed to balance the energy meridians and enhance overall metabolism.

The assessment and recommendations are offered to balance bioenergetic processes that flow through meridians known in Chinese medicine as well as other self-regulating systems. Homeopathic remedies, nutritional supplements and other natural remedies may be used to bring abnormal electrical patterns into equilibrium.

More Information about Electrodermal Screening. (Optionally) Electrodermal screening ("EDS") uses a sophisticated measuring device to interpret the bioenergetic state of health via complex measures of the electrical resistance of the skin. Electrodermal testing assists the physician/ practitioner in recommending homeopathic, herbal and other remedies based upon a reading of energetic stress responses.

This approach was originally developed by Dr. Voll of Germany in the 1920's, and is also known as Electroacupuncture According to Voll ("EAV"). While the Food and Drug Administration ("FDA") does not endorse the use of electrodermal screening and maintains that the device is only effective for testing generalized anxiety, such devices have been registered with and approved by the FDA.

An Important Word about Allergies and Sensitivities. One aspect of health that EDS measures are sensitivities to foods and materials in the environment. These sensitivities are not necessarily the same as allergies, which refer to specific immune responses (IgE, IgG, or IgM) that can only be measured by blood work or skin testing. An individual may experience that they often react to a certain food or environmental irritant, yet immune tests are negative. Because immune reactions are a complex web of interactions, it is more accurate to think of reactions to foods or items measured by EDS as sensitivities or intolerances rather than allergies. These sensitivities may or may not have a measurable immune basis but may be based upon energetic or neurological responses to various stresses. EDS is based upon the view that individuals can develop sensitivities based upon patterns of information stored energetically, an approach concerned with resonances and energy signatures rather than biochemistry or physiology.



Where any measurement refers to an energetic signature seemingly correlated with a health condition, this is for the sole purpose of clearing energetic patterns of response and does not indicate the presence or absence of any medical condition.
